in the 'Airo Eventing 2026' competition, held at the Raszyn Sports Centre on 05.09.2026.

I am aware that:

1. Participation in the "Airo Eventing 2026" is subject to the risk of accidents for participants, the consequences of which may include: bruises of all kinds, abrasions, fractures, dislocations and others.
2. Participation in the "Airo Eventing 2026" competition, like the practice of other sports, takes place as part of permissible risks, which exclude the unlawfulness of the act causing the injured participant of the "Airo Eventing 2026" the consequences referred to in point 1.
3. The organiser, all persons cooperating with him, as well as persons connected with the conduct and organisation of the competition, shall not be liable towards participants for personal, material or property losses or damage to the building/equipment occurring before, during or after the competition and therefore undertake not to assert any claims against the organiser on this account.

With the above in mind, I declare that:

- a) I and the above-mentioned underage person under my care have read the rules applicable to the competition, including in particular: "CSR Regulations" posted on https://csr.raszyn.pl/sites/default/files/paragraph_attachments.field_attachments/2023-10/regulamin_hali_sportowej.pdf and the contents of this declaration. We hereby undertake to comply fully with these rules and are aware of the consequences of non-compliance.
- b) If any material damage is caused by me or a child (underage person under my care) on the competition area (CSR), I undertake to pay all resulting costs, in particular for repairs or purchases.
- c) The organisers, as well as persons connected with the conduct and organisation of the competition, shall not be liable to participants for personal, material or property losses which occurs before, during or after the competition.
- d) I waive any claims for damages against the Stowarzyszenie Polski Związek Hobby Horse and the owner of the sports facility for incidents that occurred during the "Airo Eventing 2026" competition.
- e) Participants take part at their own risk and are liable for all damages caused by them. It is the responsibility of the parent/guardian to take out an accident insurance policy and a third-party liability insurance policy for the participant and possibly for the parent/guardian.
- f) The underage person named above on the declaration is in good health and his/her health condition allows him/her to take part in the aforementioned eventing of a sporting nature and there are no contraindications to taking part in the "Airo Eventing 2026" competition.
- g) In the event that an injury occurs to a participant in the competition and a parent/legal guardian is not present, the organiser has the right to call an ambulance. I agree to carry out any necessary treatment or surgery for conditions threatening the life or health of my child. In the event of a medical decision for hospitalisation, I undertake to collect my child from the hospital (This does not exempt the organiser from informing the parent/legal guardian of the occurrence of the accident).
- h) I give my consent to my child returning home on their own after the competition.
